**Sub: Difficulty in downloading Form 16 & pension paid statement and non-availability of pension details in pre-filled ITR**

Sir,

Following the end of deadline for furnishing of Form 16 to pensioners on 15<sup>th</sup> June 2025, efforts have been taken by the CCAs to upload Form 16 downloadable from their websites with an advice to download the pension-paid statement from the SAMPANN website.

2. But it has been reported to us from various parts of the country about inability to download Form 16 even after repeated attempts. No pension-paid statement is available in SAMPANN website too. Those who tried to proceed with filing ITR online are reporting that pension details are not available in the pre-filled ITR form, indicating that pension paid details have not yet been reported to the Income Tax department.

3. Though the last date for filing ITR has been extended up to 15<sup>th</sup> September 2025, the facility for filing ITR online is already open and the pensioners want to complete this job as early as possible. Non-availability of Form 16/pension-paid statement and pre-filled pension details in the ITR is hampering their efforts.

4. We would therefore request you to kindly ensure that the snag in downloading Form 16 is removed, pension statement is available in SAMPANN portal and pension paid details are made available in the pre-filled ITR online, at the earliest.
