Sub: Non-payment of outdoor medical claims with vouchers to the retired employees in Sangrur SSA.


Sir,

We are constraint to bring to your kind notice that the retired BSNL employees in your Sangrur SSA are facing acute problem since they are not receiving payment of their medical claims with voucher for months together. We understand that the Circle Office had released some fund to clear the pending bills, but the SSA has failed to take appropriate action in the matter. As a result, the retired employees are being forced to spend for their medical treatment out of their meagre pension which in turn is creating problem to manage their other requirements for livelihood. We enclose herewith a copy of the representation from Shri Pawan Kumar Jindal, Retd DET, Sangrur addressed to GMTD, Sangrur SSA which explains the problems being faced by the retired BSNL employees.

2 We, therefore, request you to kindly intervene in the matter so that the pending medical claims of the retired employees in Sangrur SSA are reimbursed at the earliest.

Subject:- Non-payment of outdoor medical claims with vouchers.

Resp. Sir,


With humble submission, I take this opportunity to bring to your kind notice that I am a Diabetic (DM-2) patient suffering from the last 20-22 years and taking regular medicines on daily basis and Insulin dependent. There was no problem in getting reimbursement earlier to April, 2018. But after 31st March, 2018, not even a single penny has been reimbursed against the claims submitted for myself and my wife approximately amounts to Rs.64,485/- up to 15.11.2018 from 01.04.2018 for FY.2018-19.

Under the circumstances, it has become very difficult to manage and meet with the expenses on daily use of medicines. It is learnt from reliable source that circle office has allotted about 7.0 lakhs funds to Sangrur SSA during the period 01.04.2018 to 30.09.2018 but not even a single payment of FY.2018-19 is made so far. Although, AO (Claims) O/o GMTD Sangrur assured me to make the payment of some bills in the past (probably in the month of June). It is further added that a bill amounting to Rs.8016/- for the FY.2017-18 is also pending for payment.

It is, therefore, requested to direct the concerned for making payment of all pending bills with accounts section at the earliest so as I may take proper care of my health and my family.

Hoping for needful action.
