Sir,

We would like to draw your kind attention again to non-payment of medical claims with voucher for the years 2021-22, 2022-23, 2023-24 and 2024-25 in respect of Shri S.K.Bhardwaj, Retd. EE (Civil), Bhopal in spite of his repeated representations. In response to our earlier representation cited under Ref.1 above, we were informed vide Ref.2 above that, "Unable to trace out. Please provide receiving copy so that we can trace out". In respect of some bills, it had been remarked that "In system SAP his Miss name Mrs.Neelam Bhardwaj not mentioned". Another bill was said to have been "Not paid due to fund issue". One bill dated 28.12.2024 for Rs.23561 was said to be under process.

2. Shri S.K.Bhardwaj submitted copies of the bills said to be not traceable in office immediately after that in February 2025, along with copies of Speed Post Receipts for each bill. But neither any payment has been made nor has any communication received by him regarding processing of the bills.

3. We request you to empathise with the difficulties, mental as well as financial, faced by the pensioner and to cause payment of all his pending medical claims without any more delay.
