**Sub: Withdrawal of cashless facility against indoor medical treatment from all empanelled hospitals
– Case of UP(West) Telecom Circle**

Madam,


We had earlier brought to your kind notice, vide our letter No. AIBSNLREA/CHQ/2018/58 dated 27/10/2018, that disregarding your advice, vide your No. BSNL/Admn.I/15-18/16(i) dated 10.08.2016, to all the CGMs to empanel sufficient number of CGHS approved hospitals **preferably on cashless basis for the benefit of the retired employees**, the CGMT, UP (West) Telecom Circle issued Orders on 12/10/2018 for withdrawal of cashless facility against indoor treatment from all empanelled hospitals. We also sought your kind intervention in the matter and requested to advise the CGMT, UP (West) Telecom Circle to immediately restore the cashless facilities for the retired employees.

2. Subsequently, the CGMT, UP (West) Telecom Circle has issued another order, vide No. UPT(W)/Admn-1/Genl. Corrs/2017/50 dated 29.10.2018, to continue the cashless facility only in few limited cases. This defeats the very purpose of allowing cashless facility for indoor treatment. The restrictions imposed by the UP (West) Telecom Circle, therefore, needs to be revoked at least for the retired employees. A copy of the said order issued by CGMT, UP(West) Telecom Circle is enclosed for your kind ready reference.

3. In view of the above and in continuation to our earlier submission dated 27.10.2018, we request you to kindly intervene in the matter and advise CGMT UP(West) Telecom Circle to restore the cashless facility at least to the retired employees and thus follow the spirit of your Office vide No BSNL/Admn.I/15-18/16(i) dated 10.08.2016 to empanel more CGHS approved hospitals on cashless basis to benefit the retired employees.

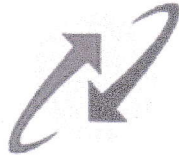
