Sub: Review of promotion from JTO (T) to SDE (T) grade on regular basis w.e.f 01.02.2001 – case of Shri Mukundbhai N. Chavda, Retd SDE (T), Surat

Ref: Our letter No.AIBSNLREA/CHQ/2025/18 dated 20.02.2025

Sir,

We hereby seek your kind attention to the long pending grievance of Shri Mukundbhai N. Chavda, Retd SDE (T), Surat, relating to review of promotion from JTO (T) to SDE (T) grade on regular basis notionally w.e.f. 01.02.2001, as per the Gujarat High Court Judgement dated 05.03.2014 and subsequent review of time bound upgradation. We have been pursuing the issue ever since it was brought to our notice more than a year ago. Shri Mukundbhai N. Chavda is struggling to get justice, even 11 years after the Gujarat High Court had delivered the verdict in his favour. Despite his repeated representations and despite this association taking up the matter with all concerned relentlessly, the issue remains unsettled. Copy of our last letter addressed to the CMD BSNL with a copy marked to the then PGM (Pers), BSNL CO is enclosed herewith, to provide detailed history of the case.

2. The issue has been unjustly and unduly delayed citing different reasons at different points of time, the last one on the plea that fresh Vigilance Clearance had been necessitated owing to expiry of previous one. According to our information fresh vigilance clearance from Gujarat Circle routed through CVO BSNL had been received in Personnel Section two months

back. But the process of conducting review DPC as per court orders and issue of promotion orders is yet to be completed, leaving the pensioner in untold suffering and distress.

3. We, therefore, request you to kindly ensure completion of the process of review of the regular promotion and subsequent time bound upgradation and consequent issue of promotion orders, without allowing the vigilance clearance to lapse again.
