1. Pursuance to letter no. BSNL/11/SR/2003(Raj)/Pt II dated 24.09.2018 & DOT Letter No.20-9/2003-STG-II Dated 07.09.2018 on the above subject and in accordance with the provisions of Rule 37-A of CCS (Pension) Rules, as amended from time to time sanction of the President is hereby conveyed to the permanent absorption of Shri RAVINDRA KUMAR TRIPATHI permanent/temporary employees of the Department of Telecommunications, in BSNL with effect from the date and under the terms and condition as indicated below.

6. **Leave :-** The Earned Leave and Half Pay Leave at the credit of Shri RAVINDRA KUMAR TRIPATHI stands transferred to BSNL on the date of absorption as provided for under Sub-rule 24(b) of Rule 37-A of the CCS(Pension) Rules.

7. **Provident Fund:** - The amount of subscription together with interest there on standing to the credit of Shri RAVINDRA KUMAR TRIPATHI in the General Provident Fund account will be transferred to his new Provident Fund account under the BSNL as provided for under Sub-rule 24(a) of Rule 37-A of the CCS (Pension) Rules as amended from time to time.

2. Shri Ravindra Kumar Tripathi SDE (Retd.) was granted only provisional permission since a CBI case was pending against the officer at the time of retirement. Now Vigilance Clearance in respect of the above officer was called from CVO BSNL vide letter no. 22-11/2018/VG/2/Retirement settlement dated 29.11.2018, the vigilance clearance in respect of the executive has been provided as granted with the following note that

1. Prosecution sanction was issued vide order no. 9-93/2002-Vig-I dated 04.08.2003. Hon'ble CBI Spl Court No. 2 Jaipur has acquitted Shri Ravindra Kumar Tripathi vide judgement dated 08.07.2016 in Spl CBI case no. 22/2011 in RC 8(A)/2001-JPR, registered on 19.03.2001. No appeal was preferred by the CBI against the acquittal order.
2. Final order no. 8-3/2003-Vig II(Pt.) dated 25.11.2008 issued imposing penalty of "Reduction by one stage in the time scale of pay for a period of one year with immediate effect" with further directions that Shri R.K. Tripathi, SDE will not earn increments of his pay during the period of such reduction and, on expiry of the period, the reduction will have the effect of postponing the future increments of his pay.
3. Order for recordable warning issued vide order No.2-20 RAJ/2010-VI III dated 25.02.2011.
3. As the officer has since been cleared from vigilance angle by CVO BSNL, the COMT NTR Telecom Circle is requested to regulate his pension and release the other retirement benefits to the officer as per para 2 above and relevant rules on the subject.
